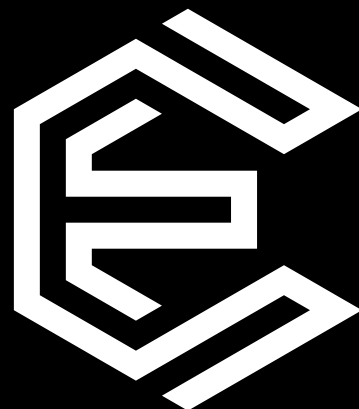

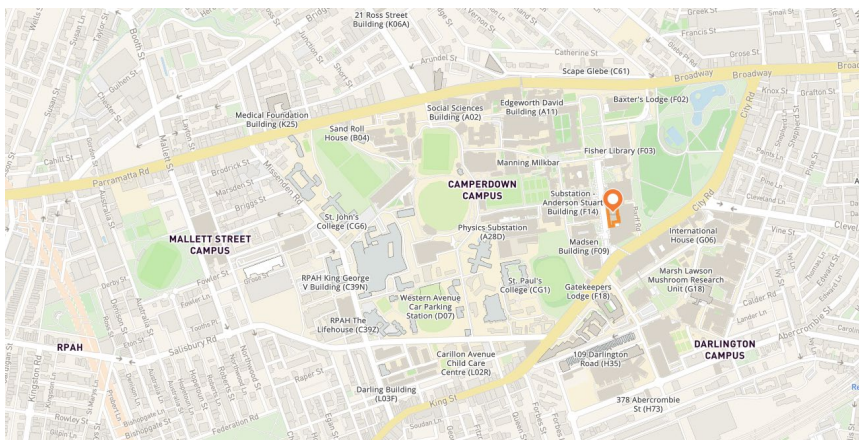

## Conference Venue

### Eastern Avenue Auditorium and Theatre Complex (F19)





The Eastern Avenue Auditorium and Theatre Complex (F19) is located on the University of Sydney's Camperdown/Darlington Campus and is easily accessible by public transport.

- **By train:** The closest station is Redfern Station (T1, T2, T3 and T8 lines), approximately a 15–20 minute walk to campus. Enter via City Road or follow campus signage to Eastern Avenue and Building F19.
- **By bus:** Numerous bus services stop along City Road and Parramatta Road, both bordering the campus. Common routes include 412, 413, 422, 426, 428, 431, 433 and 440. From these stops, it is a short walk to Eastern Avenue, with clear signage directing to Building F19.
- **Light Rail:** The Inner West Light Rail also services nearby stops, with a short walk to campus from stations such as Glebe or Jubilee Park.

## Travel from Sydney Airport to University of Sydney, Eastern Avenue Auditorium

### Public Transport – Train

Sydney Airport is directly connected to the city via the **T8 Airport & South Line**.

- Take the train from International Airport Station or Domestic Airport Station to Redfern Station. Travel time is approximately 15–20 minutes.

From **Redfern Station**, the University of Sydney is a 15–20 minute walk, or a short **bus ride** along City Road to Eastern Avenue (Check timetables prior to travel on the Opal App).

### Public Transport – Bus

- Buses operate from the airport and surrounding inner-city areas to **City Road** and **Parramatta Road**, both bordering the University of Sydney campus. From these stops, follow signage to **Eastern Avenue Auditorium (F19)** (Check timetables prior to travel on the Opal App).

### Taxi / Rideshare (Uber & DiDi)

- Taxi / Uber / DiDi** are readily available from **Sydney Airport (SYD)**. Travel time is approximately **20–30 minutes**, depending on traffic. Typical cost ranges from **AUD \$45–\$60**.

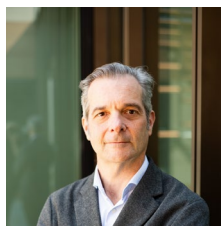

# Keynote Speakers

## Professor Erkki Autio

**Professor Erkki Autio FBA FFASL** is Chair in Technology Venturing and Entrepreneurship at Imperial College Business School, London. A leading scholar in entrepreneurship and innovation, Erkki has conducted pioneering research in areas including digital entrepreneurship, innovation ecosystems, business model innovation, and entrepreneurial resilience. His work has been cited over 60,000 times (Google Scholar), and he ranks among the top 0.2% of scientists globally in research impact. In 2024, he received the USC Helena Yli-Renko Research Impact Award for the most cited paper published in the field of entrepreneurship six years prior.



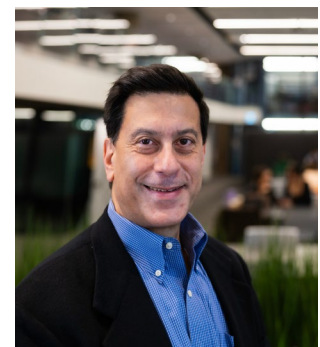
He was a co-founder of the Global Entrepreneurship and Development Institute and a key contributor to the Global Entrepreneurship Index and the EU Regional Entrepreneurship Index. He was also a founding member of the Global Entrepreneurship Monitor (GEM), the world's largest ongoing research consortium in social sciences.

Professor Autio's work has been featured in major media outlets including *The Economist*, *Financial Times*, *The Wall Street Journal*, *Forbes*, and *CNN*. He has received numerous best paper awards and was recognised as one of the 50 most influential management scholars worldwide in terms of research impact (Aguinis et al., 2012).

He has advised the European Commissioner for Innovation and Entrepreneurship and worked extensively with governments and industry in Europe and Asia on innovation policy. Four of his students' ventures have been listed among Europe's '100 Hottest Technology Ventures', and student-founded businesses under his guidance have generated billions in new market value.

## Professor Michael Lounsbury

Michael Lounsbury is a Professor, the A.F (Chip) Collins Chair, and Chair of the Strategy, Entrepreneurship and Management Department at the University of Alberta School of Business, where he is also the Academic Director of the eHUB entrepreneurship centre. He is also a Professor of Business Strategy & Entrepreneurship (Part-Time) at the Australian National University College of Business and Economics. Dr. Lounsbury is internationally-recognized as an authority in organization and management theory, and is well known for his pioneering role in developing cultural and institutional approaches to the study of entrepreneurship and social change. As one of the world's most influential researchers, he has well over 100 publications, and over 40,000 citations to his published work according to Google Scholar.



In 2018, he was elected to be a Fellow of the Academy of Management, the most prominent recognition for scholarly excellence from the main academic association in his field. In 2025, he was elected to be a Fellow of the Royal Society of Canada. At the University of Alberta, he was awarded the Martha Cook Piper Research Prize in 2010, and the J. Gordin Kaplan Award for Excellence in Research in 2020—the most prestigious University of Alberta research award. He has generated a great deal of grant funding over his career, and has recently received a \$3M grant from Innovation and Science Development Canada to develop a Canada-wide 2SLGBTQIA+ Entrepreneurship Knowledge Hub. He has previously served as Chair of the Organization and Management Theory Division of the Academy of Management. His Ph.D. is in Sociology and Organization Behavior from Northwestern University.

# Panellists and Academic Leads

## Binyam Alemayehu

Binyam Alemayehu's research spans entrepreneurship, spirituality, and leadership. He is particularly interested in how affective and behavioural factors shape individuals' evaluations of entrepreneurial opportunities, and how spiritual and religious values influence entrepreneurial action and resilience. His work also explores emerging areas such as artificial intelligence in entrepreneurship, women's entrepreneurship, migrant entrepreneurship, and entrepreneurial ecosystems in Africa. Through this multidisciplinary lens, Binyam seeks to deepen understanding of the psychological and cultural dimensions of entrepreneurship, contributing to both academic theory and practical insights for diverse entrepreneurial contexts.



## Matthew Bright

Matthew Bright is an entrepreneurial executive with extensive experience building and advising high-growth ventures across start-ups, scale-ups, internal ventures and publicly listed organisations. He brings operational expertise across new venture creation, product and market expansion, go-to-market strategy, strategic partnerships, sales leadership and distribution platform development, and managing the transition from start-up to scale-up. His professional background includes significant involvement in fundraising, corporate development, mergers and acquisitions, post-transaction integration and the establishment of new business units. Matthew has expertise spanning sector-focused venture development, investment analysis, deal evaluation, structuring and securitisation. He is active in Australia's technology start-up and scale-up ecosystem as an Entrepreneur-in-Residence, university lecturer and strategic advisor, contributing to founder development, venture growth and the translation of entrepreneurial theory into practice.



## Henri Burgers

Henri Burgers is the Head of the Strategy & Entrepreneurship Discipline at The University of Queensland. He obtained his PhD from the RSM Erasmus University, and worked at QUT prior to joining UQ. His research focuses on the intersection of corporate entrepreneurship, managerial and organisational capabilities, and institutional contexts with the aim of helping individuals and organisations unlock their entrepreneurial potential. He has published in top journals such as Strategic Management Journal, Journal of Business Venturing, Long Range Planning, and Technovation. He has worked with leading firms, industry associations and governments across the globe. His research received well over 1mil AUD in research funding, including two prestigious grants from the Australian Research Council to improve entrepreneurship and innovation in the natural resources industries. Henri teaches courses and provides workshops on strategic decision-making and agile innovation for different levels.



## Suwen Chen

Suwen Chen is a Lecturer (Assistant Professor) and Emerging Scholar Research Fellow at the University of Sydney Business School, Australia. Her research focuses on impact investing and impact measurement, social entrepreneurship, and sustain-able management, with an overarching interest in how businesses can be mobilized as forces for social and environmental good. Her work is informed by a global orientation and supported by her role as an honorary member of the Green Angel Syndicate, as well as her advisory engagements with investment firms, charities, and the United Nations Development Program. Suwen's research and commentary have appeared in leading academic journals, including the Journal of Management Studies, Entrepreneurship Theory and Practice, Journal of Business Venturing Insights, and Strategic Organization, as well as in the Financial Times, scholarly book chapters, and business cases.



## Sarah Cooper

Sarah Cooper is Professor of Entrepreneurship and Enterprise Development at the University of Edinburgh Business School, Edinburgh, Scotland. Her teaching experience spans undergraduate, postgraduate and continuing professional development communities in the UK and overseas, including Australia, China and Gulf States. She has worked extensively in the area of entrepreneurship and new venture creation, technology commercialisation and strategy, designing and delivering curriculum-based courses, and extracurricular short courses and Summer Schools on enterprise and business, both in the UK and overseas. Sarah's main research interests lie in entrepreneurship and new venture creation, with principal streams focusing on entrepreneurship, innovation and growth in technology businesses, and influences on individual motivation and capability to engage in entrepreneurial behaviour.



## Jarryd Daymond

Dr Jarryd Daymond is a Lecturer in Strategy, Innovation, and Entrepreneurship and the Academic Director (Strategic Initiatives) at The University of Sydney Business School. He also holds a Fellowship with the Higher Education Academy, serves as a convenor for the Innovation and Commercialisation node of the Sydney Policy Lab, is an Early Career Researcher Ambassador for the Sydney Nano Institute, and previously held a Strategy Research Foundation Dissertation Scholarship from the Strategic Management Society. Jarryd's collaborative approach is at the centre of his multidisciplinary research. He actively engages with scientists, engineers, biomedical researchers, and academic entrepreneurs, to collectively enhance understanding of science commercialisation processes. His unique background and practice-oriented research, coupled with his use of human-centred design, facilitated group collaboration, and lean innovation, have supported scientists in their commercialisation journeys.



## Per Davidsson

Per Davidsson is professor in entrepreneurship at the Jönköping International Business School (JIBS), Sweden, and at QUT, Brisbane, Australia. As a pioneer of entrepreneurship research, Per has led research centers in Sweden and Australia, chaired the primary professional association for entrepreneurship research globally, supervised dozens of research students and post-doctoral fellows, authored some of the best-cited works in this field, and served as associate editor of several of its leading journals. For these contributions, Per has been presented with the Global Award for Entrepreneurship Research (2023) as well as several other prestigious awards and an honorary doctorate at Leuphana University, Germany.



From his earlier work, he is known for research on firm growth, nascent entrepreneurship, the venture creation process, and entrepreneurial bricolage, among others. He currently focuses on external enablement—how various types of changes to the business environment (technological, regulatory, sociocultural, demographic, macroeconomic, natural-environmental, etc.)—provide potentials for new and improved business activities. He is the main architect behind the External Enablement concept and framework, which has triggered a new research stream into how environmental changes can be leveraged in business development.

## Manjula Dissanayake

Manjula Dissanayake is the Associate Head of Learning & Teaching - Adelaide Business School and the Academic Director – ThincLab & Entrepreneurship Programs of the University of Adelaide. He is an expert on strategising for sustainability and social impact at the Yunus Centre for Sustainability and Social Impact. He specialises in entrepreneurial learning taking a technology-centric approach to provide a flexible and personalised learning experience. He has also designed and facilitated many business accelerator/pre-accelerator programs including eChallenge program the longest-running pre-accelerator program in South Australia and Business Model Innovation program for business leaders in South Australia and Victoria. Manjula is also a certified Personal Initiative coach, the only empirically proven program to result in 30% profit growth in two years by practising business leaders.





## Antje Fiedler

Antje Fiedler is an Associate Professor at the University of Auckland Business School, specialising in entrepreneurship and international business. She is the Director of the New Zealand Asia Institute (NZAI). She is passionate about conducting research that is relevant to practice. Her research interests centre on how SMEs can productively engage with Asia. Her research has informed courses at the University of Auckland Business School and practitioner workshops across New Zealand. Antje has received three Excellence Awards for Teaching at the University of Auckland Business School. She is also a Director on the Board of the Small Enterprise Association of Australia and New Zealand (SEAAANZ) and a Board Member of the India New Zealand Business Council. She is an Editor of Small Business Economics, an Associate Editor of the Journal of Small Business Management and Review of Managerial Science, and serves on several other editorial boards, including Foundations and Trends® in Entrepreneurship and Small Enterprise Research.



## Paul Finn

Paul is an education-focussed lecturer with the Discipline of Strategy, Innovation and Entrepreneurship at the University of Sydney Business School -- a discipline that brings together academia, business, government and civil society organisations to both catalyse and research innovation and strategy. Paul designs, coordinate and teaches into the new cross-faculty Innovation and Entrepreneurship Major spanning all faculties and schools at the University of Sydney, in addition to designing and coordinating Entrepreneurship, Strategic Management, and Foundations in Strategy, Innovation and Management units of study at undergraduate and postgraduate levels. Paul researches entrepreneurship, power, and organisational creativity. He is particularly interested in 'creative' spaces, incubators, and accelerator programmes, and questions such as who -- and what -- gets to be involved in such spaces, who benefits, who doesn't, and the implications of such.



## Anna Fitzgerald

Anna Fitzgerald is a lecturer in the faculty of Strategy, Innovation & Entrepreneurship at The Sydney University Business School. She is an ex-founder and was an early employee at fintech Prospa, where she helped grow the business from scrappy startup to ASX-listed company - running the IPO process not once, but twice. She's now co-head of the Genesis Accelerator at the University of Sydney and an active startup advisor across Australia and New Zealand. Anna has worked as a fractional CMO for a number of scaleups including Silicon Valley-based ServiceRocket; and has mentored founders through Startupbootcamp's global fintech program, New Zealand's Ministry of Awesome, and is part of the AirTree Explorer program supporting early-stage investment.



## Foo Maw Der

Foo Maw Der is President's Chair in Entrepreneurship and Professor at Nanyang Business School, Nanyang Technological University. He was Director of the NTU Entrepreneurship Academy (NTUpeneur) from 2022–2025 and also served as Acting Associate Vice President (Entrepreneurial Education). He teaches leadership, management, and entrepreneurship, and holds a BBA (Honours, Second Upper) from the National University of Singapore and a PhD from the Massachusetts Institute of Technology.

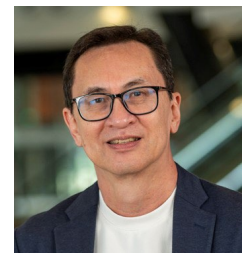
## Murray Gillin

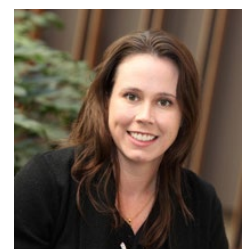
## Timothy Hor

Timothy Hor is an Assistant Professor at RMIT University's School of Management, bridging three decades of entrepreneurship practice across venture creation, scale-ups, and innovation leadership in the Asia-Pacific with research on entrepreneurial judgment, agency, and ethical decision-making in technology-intensive contexts. His current work addresses a central challenge in business education: when AI can generate pitch decks, business plans, and market analyses on demand, what becomes of traditional entrepreneurship pedagogy? Rather than treating generative AI as a threat or shortcut, Timothy reframes it as a cognitive partner that amplifies learning while foregrounding distinctly human capabilities including problem framing, moral reasoning, contextual judgment, and reflective sense-making under uncertainty. He has led the redesign of multiple MBA and executive programs around this human-centric, AI-first approach, translating emerging technologies into pedagogically rigorous learning models.



## Anna Jenkins

Anna Jenkins, an Associate Professor in Entrepreneurship and Innovation at the University of Queensland, Australia. Her research focuses on how entrepreneurs navigate the process of starting, managing and exiting their firms. She researches the impact and implications of firm failure for owner-managers, and her recent work takes a process and practice perspective to understand new venture emergence. She currently holds two prestigious Australian Research Council Grants having brought in over 7.5 million in research funding during her career. She has published in Journal of business Venturing and International Small Business Journal, among others, and sits on the editorial review boards of Journal of Business Venturing and Entrepreneurship Theory and Practice.

His research examines person–environment interactions shaping human agency, with a focus on entrepreneurship, innovation, and AI, and is widely published and internationally recognised.



## Krithika Randhawa

Krithika Randhawa is Associate Professor of Strategy, Innovation and Entrepreneurship and an Australian Research Council (ARC) Research Fellow at the University of Sydney Business School. Her research sits at the intersection of innovation strategy, digital technologies, and entrepreneurship, examining how corporates and startups adopt, commercialize, and scale emerging technologies through open innovation. ## Dean Shepherd

Dean Shepherd is the Ray and Milann Siegfried Professor of Entrepreneurship at the Mendoza College of Business, Notre Dame University. ## Paul Steffens

Dr Paul Steffens is Professor of Entrepreneurship and Director of the Entrepreneurship, Commercialisation and Innovation Centre (ECIC), The University of Adelaide, Australia. He is also the inaugural president of the Australasian Consortium for Entrepreneurship Research Excellence (ACERE), the peak membership association of Entrepreneurship and Innovation academics, and Otto Mönsted Visiting Professor at the University of Southern Denmark. His current research is concerned with the creation, development and growth of new ventures, the psychology and behaviour of entrepreneurs, and entrepreneurial ecosystems. He has been a chief investigator for several major research programs totalling over AUD 2 million, including the Comprehensive Australian Study of Entrepreneurial Emergence (CAUSEE) and the Australian Global Entrepreneurship Monitor (GEM). Paul has engaged closely in collaborative research with both the South Australian and Commonwealth Governments in areas of entrepreneurship policy and programs. 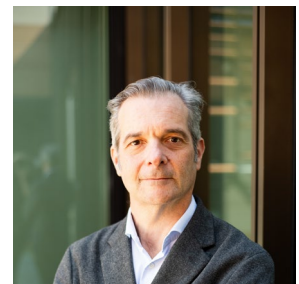
## Mile Terziovski
